- 1. The personnel list of chair is composed with the workload of on average not more than 700 hours per one lecturer.
- 2. The chair workload distribution among lecturers is carried out by the head of chair in coordination with the dean; it is approved by the vice-rector on academic affairs.
- 3. The chair workload shall correspond to the following requirements:
- a) lectures shall compose not less than 120 hours within the workload of a professor,
- b) auditorium (lecture, practical, seminar, laboratory class) hours shall compose not less than 240 hours within the workload of an associate professor,
- c) the time amount allotted for exams and pass-fail exams shall not exceed 30% within the workload of a professor, associate professor, assistant and lecturer,
- d) 120 hours at the expense of practical, seminar or laboratory courses of the chair shall be allotted for 2^{nd} and 3^{rd} -year postgraduate students in the course of their learning as a pedagogical work placement (60 hours per an academic year).
- 4. The lecturers invited for teaching by internal and external joint appointments can be designated at a rate of up until 0,5 or on the basis of hourly payment.
